

Blitz United Soccer Academy Registration Form



Blitz United Soccer Academy ('BUSA') is the player development academy within Tulsa United Soccer Club, open to players throughout Green Country. The purpose of BUSA is simple; train and develop players in ball-handling, passing, and shooting skills. This training program is focused on increasing speed, agility, and strength in order to build confidence within each player. Registered players will be assigned to teams within their appropriate age and gender. Players will be assigned to teams for games and tournaments, however the players within each age group will train as a single program. Each academy team will train on average, twice weekly, and will play games within an organized league. Additional friendly matches and tournaments are also a part of the BUSA program.

League registration for BUSA players are set according to season fees and are simply passed onto the player. Each registered BUSA player is responsible to pay team fees at \$35 monthly, at least for one complete season, either Fall, Winter, or Spring. Registration fees are \$10 per player, and will include one BUSA t-shirt. Additional US Club or USYSA registration may also be required. Monthly team fees are due by the 5th of each month.
